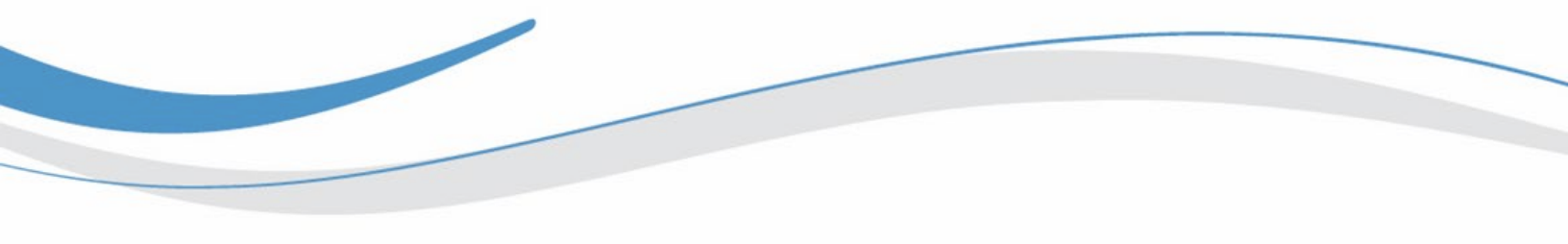

2. Not to cover the Aldergrove Credit Union logos on the tent at any time.
3. Not to permit any emissions-producing appliances to be used in the tent(s), e.g. stoves, barbecues, heaters, etc.

Please Note: If breached, charges for cleaning and/or damages to the tent fabric will be the responsibility of the community organization

4. Not to permit any alcoholic beverages to be served from or consumed in the tent(s).
5. Not to attach or hang anything to the supports or fabric of the tent(s).

Please Note: Applying tape or glue to the tent fabric and/or frame may result in cleaning charges that will be the responsibility of the community organization.

6. To return the tent(s) to Tent Guys Tent Rental Ltd at the conclusion of the event in the same condition as when supplied.
7. If the tent(s) is/are requested for overnight use security **MUST** be provided at the expense of the community organization to avoid theft or vandalism.
8. Tent set-up is up to the discretion of The Tent Guys Tent Rentals Ltd.
9. If the event is cancelled the organizer(s) **MUST** notify Aldergrove Financial Group immediately. If cancellation occurs after The Tent Guys Tent Rentals Ltd. has contacted the organizer, then the organizer must notify them as well.

Please Note: Failure to notify Aldergrove Financial Group and/or Tent Guys Tent Rental Ltd may result in a set-up charge that will be the responsibility of the community organization
